**WITHOLDING PERIOD:** Number of days which should be allowed between the last application and harvesting or grazing (feeding) of the crop:

<b>APPLES AND PEARS</b> Scab ( <i>Venturia inaequalis</i> )	<b>150 - 200mℓ / 100 ℓ water</b>	<b>Pre-blossom:</b> Start application at green-tip stage and repeat at 7 day intervals. <b>Post-blossom:</b> Continue with 3 - 4 applications depending on weather conditions and with 10 - 14 day intervals. Use the higher dosage rate under high infestation pressure. <b>Note:</b> FARMAG CAPTAN 500 SC may cause leafspots on Pearmain, Delicious, Cox and other sensitive cultivars
<b>OLIVES</b> Leaf spot ( <i>Cycloconium oleaginum</i> )	<b>150 - 200mℓ / 100ℓ water</b>	Apply two high volume applications to the point of runoff. Apply one in spring before the new flush appears and then a second in autumn before the start of winter.
<b>TOBACCO SEEDBEDS</b> <b>Anthraxnose</b> ( <i>Colletotrichum destructivum</i> )  <b>Black root rot</b> ( <i>Thielaviopsis vasicola</i> )  <b>Black shank</b> ( <i>Phytophthora nicotianae</i> )  <b>Damping-off</b> ( <i>Pythium, Fudarium and Rhizoctonia spp</i> )	<b>200mℓ / 100ℓ water</b>	Apply 15 ℓ / 10m <sup>2</sup> as a soil drench 3 weeks after germination and wash into the soil with 40 ℓ of water.
